

**INFORMATION POLICIES ON THE PROCESSING PERSONAL DATA
(Articles 13 and 14 of the EU Regulation 2016/679 hereinafter "Regulation")
NEWSLETTER AND CONTACT**

In this document, we inform you with regard to the characteristics of the processing of your personal data carried out by Fabrick S.p.A. (hereinafter the "Company") for the forwarding of the Fabrick newsletter and commercial contacts. In particular, information is provided concerning the following:

1) Who is the Data Controller?

The Data Controller of your personal data is Fabrick S.p.A. (hereinafter, the "Owner") headquartered in Biella (BI) - 13900, in Piazza Gaudenzio Sella, n. 1 (Italy).

2) How to contact the Data Protection Officer?

The Data Protection Officer (hereinafter also the "DPO - Data Protection Officer") can be contacted at the following addresses:

3) What data are, or can be, processed?

The processing relates to your personal data belonging to the following categories:

- identification and socio-demographic data (such as: name, surname, data relating to occupation / profession and to the company to which they belong);
- contact details (such as: telephone number, e-mail address).

The data listed above are directly provided by you to the Company or through third-party companies or social networks (e.g., by filling in specific online forms for entering data or following direct contact with the Company personally or by telephone or email).

4) For what purposes are the data processed and on what legal bases?

The processing is carried out in compliance with the conditions of lawfulness provided for by the Regulations and is limited to what is necessary for the Company and / or third parties, on behalf of the same, to carry out the activities connected and instrumental to:

- the automatic and free sending of the newsletter to the e-mail address indicated by you.
- contact you by e-mail or telephone to offer you the Company's products and services.

The aforementioned treatments are carried out exclusively in the presence of specific and separate consents, without which it will not be possible to carry out the activities described above. You can withdraw your consent at any time in the manner indicated in the paragraph "What are your rights?" or by means of a specific option available at the bottom of each e-mail, without affecting the lawfulness of the processing carried out before the revocation.

Within the limits of the specific purposes indicated above, the processing is carried out using manual, IT and telematic tools. The Company adopts adequate organizational and technical measures to ensure the security and confidentiality of your personal data.

5) To whom can the data be disclosed?

Your personal data will be processed, via suitable methods and procedures, by employees and collaborators of the Company and will not be disclosed. For the same purposes expressed in paragraph 4, your personal data could also be processed by the Company's suppliers (by way of example: platforms for the forwarding of marketing e-mails, companies that support the Company in carrying out promotional activities for their products or services, companies that provide CRM software). These entities, if the conditions are met, are nominated as Data Processors pursuant to art. 28 of the Regulation.

6) Can data be transferred to countries outside the European Economic Area?

For the pursuit of the purposes referred to in paragraph 4, your personal data will be transferred outside the European Economic Area, through the Company's suppliers. The transfer takes place, in compliance with the provisions of the law, by virtue of agreements that comply with the standard contractual clauses for the transfer of personal data adopted by the European Commission. Further information on the transfer can be requested in the manner referred to in the paragraph "What are your rights?".

7) How long are the data stored?

The treatment will have a duration necessary for the pursuit of the purposes for which your data were provided. In particular:

- the data processed for the forwarding of the newsletter will be processed and stored for the entire period in which the service is active or until your possible withdrawal of consent;
- the data processed to contact you by e-mail or telephone and offer the Company's products and services will be processed and stored for 24 months.

8) What are your rights?

We inform you that you will be able to know which personal data are processed by the Company and, where the conditions apply, exercise the rights relating to their use that are recognized by the Regulations (right of access, rectification, cancellation, limitation to processing, portability, to revoke the consent to the processing and obtain a copy of the adequate guarantees adopted in which the data are processed in countries outside the European Economic Area, as well as obtain an indication of the place where such data are stored or transferred, as well as oppose for legitimate reasons to a particular treatment), by contacting:

We also inform you that, if you believe the processing of data concerning you violates the Regulations, you can lodge a complaint with the Guarantor Authority for the protection of personal data (hereinafter, the "Guarantor"), in the manner indicated on the site of the Guarantor himself.

The Company provides you with information relating to the action taken regarding your request without undue delay and, at the latest, within one month of receipt of the same.
